PROPOSED ORDINANCES

I. REPEAL OF ARTICLE XXIII. WATER POLLUTION CONTROL AUTHORITY

Effective August 1, 2024, the following ordinances shall be repealed:

~~Sec. 2-145. Established; powers, duties generally.~~

~~Pursuant to the authority granted by Section 7-246 of the Connecticut General Statutes, as amended, there is hereby created a water pollution control authority for the City of Ansonia, which shall be vested with all of the powers, duties and authority of sewer authorities as provided in the Connecticut Statutes, any special acts relating thereto and the Ansonia City Charter except that no sewer connections for projects beyond the city's boundaries be allowed without approval of the board of aldermen.~~

~~Sec. 2-146. Composition; appointment and term of members.~~

- ~~(a) The authority shall be comprised of seven members who shall be appointed by the mayor and confirmed by the board of aldermen.~~
- ~~(b) Members of the authority shall be appointed to serve for a term of three years, except that initially the members shall serve terms as follows: two members for one year; two members for two years; and three members for three years, commencing January 1, 1989. Annually, thereafter, members shall be appointed to a term of three years. Vacancies shall be filled for the unexpired term in the same manner as the original appointment. Membership shall include one member of the board of aldermen and one member of the board of public works.~~
- ~~(c) All members of the authority shall serve without compensation.~~
- ~~(d) A member shall be removed from office for incompetency, neglect of duty, misconduct or other grounds contained in Section 151 of the Ansonia City Charter as other officers of the city.~~
- ~~(e) The authority shall select from its members a chairman, vice chairman, secretary and treasurer, each of whom shall serve for one year. Membership shall include one member of the board of aldermen and one member of the board of public works.~~

**II. REPLACEMENT OF ARTICLE XXIII. WATER POLLUTION CONTROL
AUTHORITY**

NEW SEC. 2-145 Effective August 1, 2024, the Ansonia Board of Aldermen shall assume all powers, duties and responsibilities of the former Ansonia Water Pollution Control Authority, and shall act as Ansonia's water pollution control authority pursuant to Section 7-246 of the Connecticut General Statutes.
